SENIOR MANAGEMENT PROGRAMMELEADERSHIP AND GOVERNANCE

In the 21st Century, Asian nations and societies have begun to gain new influence on the world stage. At the same time, economies in Asia and across the globe are struggling to maintain their growth and development during the ongoing economic crisis. The challenge will be for systems of governance to keep pace with and adapt to the new realities, which are shaped by changing international dynamics and rapid, technology-driven globalisation. To help meet this challenge, the School of International and Public Affairs at Columbia University, New York and the Lee Kuan Yew School of Public Policy at the National University of Singapore have brought together a distinguished team of academics and policymakers to offer a month-long Senior Management Programme (SMP) on Leadership and Governance.

This programme is jointly developed by the Lee Kuan Yew School of Public Policy at the National University of Singapore and the School of International and Public Affairs at Columbia University, New York.

PROGRAMME OBJECTIVES

The Senior Management Programme (SMP) gives government and business leaders the opportunity to step back from their day-to-day responsibilities and embark on a journey of intellectual and personal renewal to improve their performance as leaders in their respective organisations.

SMP participants can expect to:

- Gain broader perspectives and heightened awareness of the impact of external forces on their organisations;
- Sharpen leadership abilities and improve selfawareness to lead and inspire better;
- Acquire new management approaches and strategic frameworks to improve their organisations' performance levels;
- Apply what they have learned to a real world case during a one week field trip;
- Establish a valuable network of global peers from diverse backgrounds who will help expand their horizons and opportunities.



PARTICIPANT PROFILE

The SMP is designed for senior executives in the government, non-profit and private sectors, who are poised to become the next generation of leaders in their organisations.

The ideal SMP candidate is a senior functional head or director of an organisational unit with at least eight years of significant managerial experience.

As the programme will be conducted in English, participants must be proficient in the language.

PROGRAMME OVERVIEW

The Senior Management Programme (SMP) explores global challenges, pertinent topics and fundamental issues that affect decision making and leadership. It leads participants through a four-week journey of learning and reflection across the following thematic areas:

- Global Challenges and Opportunities
- Government, Business and Society: The Enterprise as a Vehicle for Social Change and Economic Development
- New Approaches for New Leaders

The SMP also includes an innovative experiential module run in collaboration with our partner the Global Institute for Tomorrow (GIFT), which is described in greater detail in the facing page.

The aim of the SMP is to provide participants with a holistic learning experience across a gamut of pertinent topics and equip them with the skills they require to have a positive impact on their organisations and society at large.

The SMP is anchored in the premise that the individual leader has the potential to exercise positive influence in guiding organisations. Hence the programme places great emphasis on enhancing participants' awareness of their strengths and weaknesses when interacting with others.

Although the individual is central to the programme, leadership is not exercised in a vacuum. Thus in addition to understanding one's leadership style and approach, it is also important to accurately assess the context in which a leader operates. This is why the programme also focuses on organisational dynamics and understanding the global forces affecting organisations and the world today.





THE LEARNING MODEL

Practical Application is key. Our faculty's approach emphasises interactive teaching methods, including simulations, case studies, debates, and panel discussions, in addition to the presentation of new analytical frameworks, with the aim of engaging participants as experienced practitioners. Together, the stellar cast of faculty brings with them a wealth of global experience and diverse perspectives.

Networking & Interaction with global peers from diverse backgrounds is integral to the programme. The participants themselves contribute significantly to each other's learning experience. With the diversity in their backgrounds, organisations, countries and perspectives, they contribute to the richness of discussion both inside and outside the classroom.

Exclusive Closed Door Discussions with senior business and government leaders is another highlight of the programme. The leaders share with participants their insights and experience in leadership, global issues and organisational challenges.

GLOBAL LEADERS MODULE

The Global Leaders Module is an experiential leadership development programme run in partnership with the Global Institute For Tomorrow (GIFT). This will be the third year of collaboration between GIFT and the LKY School of Public Policy. As a distinct feature of the Senior Management Programme (SMP), this integrated module offers a unique opportunity for participants to tackle a development challenge in a real-life public-private partnership setting in Asia. During the experiential module, participants are required to apply the leadership skills and knowledge acquired from the classroom discussion in the first few weeks of the programme to create a viable strategic plan that resolves implementation hurdles associated with a development project.



In 2010, the Global Leaders Module brought the 22 SMP participants to Phnom Penh, Cambodia and provided them an opportunity to apply business principles and leadership skills towards developing an innovative, sustainable, and market-based solution to the problem of poor-quality drinking water throughout Cambodia. The final output of their work was a strategic recommendation in the form of a robust business plan which can be taken forward by Hydrologic for implementation. At the conclusion of the programme, participants presented the results of their work as a final business plan at a Social Business Opportunity Briefing in Singapore, on Friday, 23 July 2010. This event served as a culmination to the week-long programme for participants and also brought together key potential investors and business partners.

The methodology of the Global Leaders Module is to use business skills to provide a socially, environmentally and economically viable solution to an existing issue in the development space. In 2011, participants will be working on a project in Asia that is linked to globalisation issues such as public health, community development, environmental management, sustainable development, or natural resource conservation in a public-private partnership framework.



The Global Leaders Module will be facilitated by Chandran Nair and staff from GIFT. Participants will be encouraged to use their own professional experiences with the insights acquired in the classroom module into the strategic planning process. The programme will culminate in a mini investor conference to present the strategic plan to an audience of representatives from the public and private sectors.

The costs (travel, accommodation and meals) associated with this week-long overseas learning segment are already included in the Senior Management Programme fee.



CORE FACULTY

The SMP brings together a stellar team of academic experts and senior practitioners from the Lee Kuan Yew School of Public Policy at the National University of Singapore and the School of International and Public Affairs at Columbia University. Together they brought a wealth of global experience and multiple perspectives to this programme.



Scott FRITZEN is Vice-Dean (Academic Affairs) and Associate Professor at the Lee Kuan Yew School of Public Policy (National University of Singapore). He specializes in the analysis of governance reform and capacity strengthening in developing countries. His current research focuses on the comparative analysis of anticorruption strategies, public sector decentralization and social policy reforms in Southeast Asia. At the LKY School of Public Policy, where he has taught since 2000, he teaches courses in public management, negotiation and conflict management, public sector reform in developing countries, and strategies for poverty alleviation. His active consulting practice since 1994 in Southeast Asia has included over 35 assignments – most of which as team leader - for clients such as the World Bank, UNDP and Oxfam, among many others. He was the first American in the post-war era designated a Fulbright Fellow for Vietnam, and has lived and worked for extended periods in Japan, Germany, Zimbabwe, and Vietnam. His Master in Public Affairs and Urban and Regional Planning degree and Ph.D. in Public Affairs are both from the Woodrow Wilson School of Public and International Affairs, Princeton University.

John BECK is a Visiting Professor at the Lee Kuan Yew School of Public Policy at the National University of Singapore. He is also President of the North Star Leadership Group, a Senior Research Fellow at University of Southern California's Annenberg Center for the Digital Future, and a Senior Advisor at Monitor Group. Dr. Beck was formerly Director of International Research at Accenture and served as the Dean of Globis University (Japan). He was also a Professor of Global Management & Director of Research

at Thunderbird School of Global Management, where he is now a Global Financial Services Center Senior Research Fellow. Dr. Beck earned his B.A. in East Asian Studies and Sociology summa cum laude from Harvard University, and was the first graduate of Harvard's integrative Ph.D. program in Organizational Behavior. Dr. Beck is a Visiting Professor at IMD (Switzerland), IPADE (Mexico) and ESMT (Germany). Dr. Beck has also taught at numerous other universities like: Harvard, UCLA, USC, and the Ivey School in Canada. Dr. Beck served as the senior strategic advisor to the First Prime Minister, Prince Ranariddh, during Cambodia's first three years as a democracy. He has written six books and hundreds of articles: including: The Attention Economy, DoCoMo, Got Game, Japan's Business Renaissance, and The Kids are Alright.

William EIMICKE is the founding Director of the Picker Center for Executive Education at Columbia University's School of International and Public Affairs. He has authored or co-authored four books and numerous articles on public management innovation, ethics, competition and privatisation. Dr. Eimicke has served as director of Fiscal Studies for the New York State Senate, assistant budget director of the City of New York, deputy commissioner of the New York City Department of Housing Preservation and Development, New York Governor Cuomo's Deputy Secretary for Policy and Programs, and New York State Housing Commissioner.



Boyd FULLER is an Assistant Professor at the Lee Kuan Yew School of Public Policy of the National University of Singapore. His research focuses on the resolution of difficult public policy conflicts where stakeholders have apparently irreconcilable differences. Dr. Fuller's current research probes the use of traditional and innovative dispute resolution techniques for peacebuilding and reconstruction in post-conflict areas of Southeast Asia. His previous research examined the mediation of intractable environmental conflicts in the United States. Dr. Fuller has eight years of experience designing and implementing water supply projects in developing countries. He completed his Ph.D. at the Massachusetts Institute of Technology.

Darryl JARVIS specialises in risk analysis and the study of political and economic risk in Asia, including investment, regulatory and institutional risk analysis. He has authored and/or edited several books and has contributed articles to leading international journals. He has been a consultant to various government bodies and business organisations, and for two years was a member of the investigating team and then chief researcher on the Building Institutional Capacity in Asia (BICA) project, commissioned by the Ministry of Finance, Japan. His current research is a large cross-national study of risk causality in four of Asia's most dynamic industry sectors. He teaches courses on risk analysis, markets and international governance, and international political economy.



LAM Chuan Leong is the Ambassador-at-Large with the Ministry of Foreign Affairs. He is also concurrently the Chairman of the Infocomm Development Authority of Singapore and Chairman of the Competition Commission of Singapore. His key areas of interest and expertise are in the application of general management theories and also of micro-economics, particularly in regard to regulation of monopolies, competition policy, pricing and market efficiency, privatisation of government services, transport economics, and the structuring of public as well as private financing initiatives. Mr. Lam held the post of Permanent Secretary in the Ministry of Finance, Ministry of the Environment, the Ministry of National Development, the Ministry for Trade and Industry, and the Ministry of Communications and Information. From 1981 to 1984, he served as Principal Private Secretary to the Prime Minister of Singapore.

Arvid LUKAUSKAS is the Director of Programme in International Economic Policy and Management at the Picker Center for Executive Education in Columbia University's School of International and Public Affairs. Dr. Lukauskas specialises in international and comparative political economy. His recent publications include the books, The Political Economy of the East Asian Crisis and Its Aftermath (ed. with F. Rivera-Batiz) and Regulating Finance

as well as numerous articles on political economy, financial policy and central banking. He has served as a consultant to the United Nations Development Programme and the World Bank.

Kishore MAHBUBANI was appointed Dean of the Lee Kuan Yew School of Public Policy on 16 August 2004 after having served 33 years in the Singapore Foreign Service (with postings in Cambodia, Malaysia, Washington DC and twice as Ambassador to the UN, during which he also served as President of the Security Council). He was Permanent Secretary of the Foreign Ministry from 1993-1998. He is the author of the book Can Asians Think?, published in Singapore, Canada, US, Mexico, India and the People's Republic of China and of Beyond The Age of Innocence: Rebuilding Trust between America and the World. He is also the author of The New Asian Hemisphere, published in February 2008. He was named in 2010 as one of Foreign Policy's top 100 Global Thinkers for being the voice of a new Asian Century.

Brian MANDELL is a Senior Lecturer in Public Policy and Director of the Kennedy School of Government's Negotiation Project. He is also Chair of the Wexner-Israel and Kokkalis Fellowship programmes at the School. His current teaching and research address the theory and practise of negotiation, emphasising third party facilitation and consensus building in domestic and international protracted policy disputes. He writes about contentious disputes and is completing a book on scenario planning for conflict managers and negotiation practitioners. Before joining Harvard, Dr. Mandell taught at the Norman Paterson School of International Affairs at Carleton University in Ottawa. Previously, he was a strategic analyst for the Canadian Department of National Defence, specialising in UN peacekeeping and the implementation of arms control agreements. A Pew Faculty Fellow and Senior Research Associate at the Kennedy School's Belfer Center for Science and International Affairs, Dr. Mandell holds a PhD from the University of Toronto.



Jonathan MARSHALL has research interests in leadership, peak performance, and the mind-body connection. At the Harvard Business School he worked closely with the faculty, staff, and students to facilitate higher levels of individuals' personal and career performance. His doctorate, at Stanford University, focused on the use of hypnosis and meditation to improve mood and wellbeing. Prior to his current appointment, he helped build the new psychology division at the Nanyang Technological University. Currently, he conducts research on how individual leaders are perceived and teaches courses on leadership development.

Chandran NAIR is the Founder and Chief Executive of GIFT. Corporate and government leaders seek his advice on how to meet the challenges of doing business in Asia as well as on leadership development, ethics, sustainability, and corporate social responsibility. For more than a decade, Mr. Nair has strongly advocated a more sustainable approach to development in Asia, and he has helped governments and corporations instill these principles into their key decision making processes. He is a frequent speaker at forums around the world, notably at speaking engagements in London, New York, Sydney, and all the major Asian capitals. He is also a fellow of the Royal Society of Arts (RSA) and the Hong Kong Institute of Directors. Mr. Nair has written widely including opinion pieces for international publications such as the Financial Times. He is currently working on a book titled "Consumptionomics: Asia's role in reshaping capitalism and saving the planet."

Stavros YIANNOUKA is the Executive Vice-Dean for Executive Education of the Lee Kuan Yew School of Public Policy. His areas of interest include leadership, European and Middle Eastern history and current affairs. Prior to joining the School, Mr. Yiannouka was a senior consultant with McKinsey & Company. Based in Singapore, he served a wide range of major public sector clients, in areas such as financial services, healthcare and higher education. Before joining McKinsey & Company, Mr. Yiannouka practiced corporate and commercial law in the City of London and is still a member of the Law Society of England and Wales.


